Regulations

1. These Regulations may be cited as the Motor Traffic (Driving Licence Levy) Regulations No. 03 of 2022.
2. The levy payable for the purposes specified in *Column I* of Schedule I to these regulations in respect of the normal service and same day service, shall be as specified in the corresponding entries in *Column II* and *Column III* respectively of that Schedule.
