THE NATIONAL MEDICINES REGULATORY AUTHORITY ACT, No. 5 OF 2015

REGULATIONS made by the Minister of Health under Section 142 of the National Medicines Regulatory Authority Act, No. 5 of 2015.

Regulations

The Medicines (Ceiling on Prices) Regulations, 2019 published in the *Gazette* Extraordinary No. 2123/35 of May 15, 2019, as amended by regulations published in *Gazette* Extraordinary No. 2241/43 of August 19, 2021 are hereby amended as follows: -

- (1) by the repeal of regulation 1 thereof and the substitution therefor, of the following: -
 - "1. These regulations may be cited as the Medicines (Ceiling on Prices) Regulations, 2019.";



- (2) by the repeal of regulation 2 thereof and the substitution therefor, of the following: -
 - "2. The maximum retail price of the medicines in generic name specified in Column II of the Schedule hereto (hereinafter referred to as the "Scheduled Medicines") in the dosage form or route of administration specified in the corresponding entry in Column III thereof of the strength specified in the corresponding entry in Column IV thereof shall be as specified in corresponding entry in Column V of the Schedule hereto.";
- by the repeal of regulation 3 thereof and the substitution therefor, of the following: -
 - "3. The maximum retail price of the Scheduled Medicines shall be applicable to all the brand names of the generic name of such Scheduled Medicines.";
- (4) by the repeal of regulation 4 thereof and the substitution therefor, of the following: -
 - "4. A manufacturer, importer, trader, distributor, pharmacist, medical practitioner, dentist, veterinary surgeon, medical institution including a private medical institution, pharmacy or person who or which is in possession of the Scheduled Medicines, for the purpose of sale shall not sell such Scheduled Medicines above the maximum retail price specified in Column V of the Schedule or revised retail price as may be determined in accordance with the provisions of regulation 6.";
- (5) by the repeal of regulation 6 thereof and the substitution therefor, of the following: -
 - "6. (1) On the date of publication of these regulations, a manufacturer or importer who sells any Scheduled Medicine except paracetamol at a revised retail price under the Medicines (Ceiling on Prices) Regulations of 2019 published in Gazette Extraordinary No. 2123/35 of May 15, 2019 as amended by the regulations published in Gazette Extraordinary No. 2241/43 of August 19, 2021 which is less than the maximum retail price specified in Column V of the Schedule to the Medicines (Ceiling on Prices) Regulations of 2019 published in Gazette Extraordinary No. 2123/35 of May 15, 2019 may increase proportionately such revised retail price by a total thirty-eight per centum (38%). The total increase of thirtyeight per centum (38%) includes the nine per centum (9%) increased by regulations published in Gazette Extraordinary No. 2241/43 of August 19, 2021 and the other twenty-nine per centum (29%) increased by these regulations.
 - (2) (a) On the date of publication of these regulations, a manufacturer or importer who sells a paracetamol at a revised retail price under the Medicines (Pricing of Paracetamol Tablets/Capsules 500mg) Regulations, 2022 published in Gazette Extraordinary No. 2269/11 of February 28, 2022 which is less than the maximum retail price specified in Column V of the Schedule hereto may increase proportionately such revised retail price by a total twenty-nine per centum (29%).
 - (b) For the avoidance of doubt, it is hereby declared that the total increase of thirty-five per centum (35%) by the Medicines (Pricing of Paracetamol Tablets/Capsules 500mg) Regulations, 2022 published in *Gazette* Extraordinary No. 2269/11 of February 28, 2022 included the increase of nine per centum (9%) of the paracetamol increased by regulations published in *Gazette* Extraordinary No. 2241/43 of August 19, 2021.
 - (3) Notwithstanding the provisions of sub-regulations (1) and (2), such increase of revised retail price of the Scheduled Medicines shall not exceed the maximum retail price specified in Column V of the Schedule hereto.
 - (4) Every trader, distributor, pharmacist, medical practitioner, dentist, veterinary surgeon, medical institution including a private medical institution, pharmacy or person who or which is in possession of the Scheduled Medicines the purpose of sale shall maintain the price of the Scheduled Medicines at the maximum retail price or revised retail price whichever is less.";

- 6. by the repeal of regulation 7 thereof and the substitution therefor, of the following: -
 - "7. Where any dosage form or strength of the Scheduled Medicines and the maximum retail price of such dosage form or strength of Scheduled Medicines are not specified in Column V of the Schedule hereto, the National Medicines Regulatory Authority shall fix the price for the Scheduled Medicines in such dosage form or strength.";
- 7. by the repeal of regulation 8 thereof and the substitution therefor, of the following: -
 - "8. Any manufacturer or importer shall print or mark on the commercial package or label of the Scheduled Medicines the maximum retail price specified in Column V of the Schedule hereto, or the revised retail price, whichever is less, in the stock manufactured or available in the market as expeditiously as possible:

Provided however, the maximum retail price or the revised retail price whichever is less shall be printed or marked in the commercial package or label of the Schedule Medicines before the expiry of a period of forty-five days from the date of publication of these regulations.";

- 8. by the repeal of regulation 9 thereof:-
- 9. by the repeal of regulation 10 thereof and the substitution therefor, of the following: -
 - "10. Any person who contravenes the provisions of these regulations commits an offence and shall be triable under section 131 of the National Medicines Regulatory Authority Act, No. 5 of 2015.
- 10. by the repeal of regulation 11 thereof and the substitution therefor, of the following: -
 - "11. It shall be the duty of every manufacturer, importer, trader, distributor, pharmacist, medical practitioner, dentist, veterinary surgeon, medical institution including a private medical institution, pharmacy or person who or which is in possession of the Scheduled Medicines for the purpose of sale, to display at every retail outlet the maximum retail price of the Scheduled Medicines or the revised retail price whichever is less.";
- 11. by the insertion of definition for the term of expression "person", immediately after definition of "medical practitioner"

"person" includes any body of persons corporate or unincorporate;"; and

12. by the repeal of the Schedule and the substitution therefor, of the following: -
